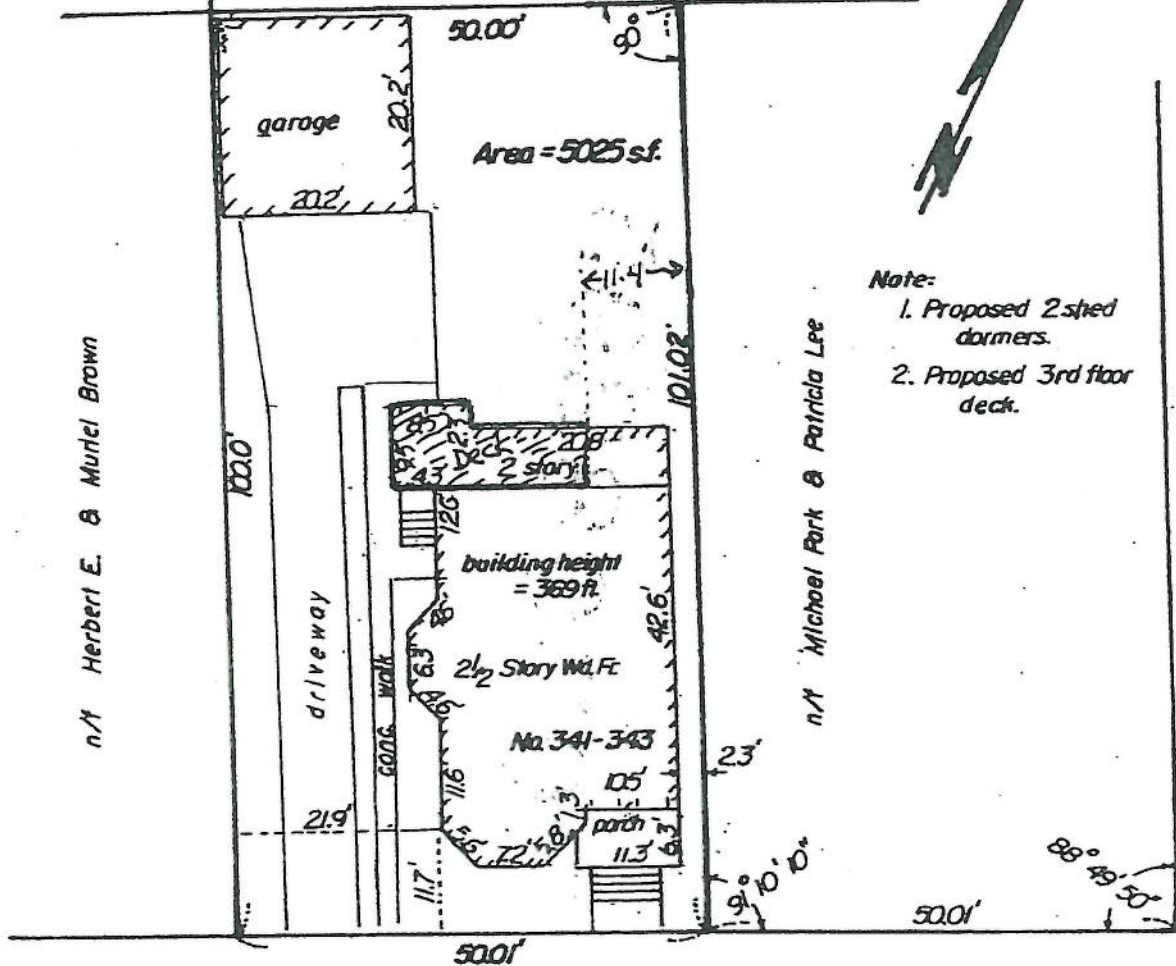

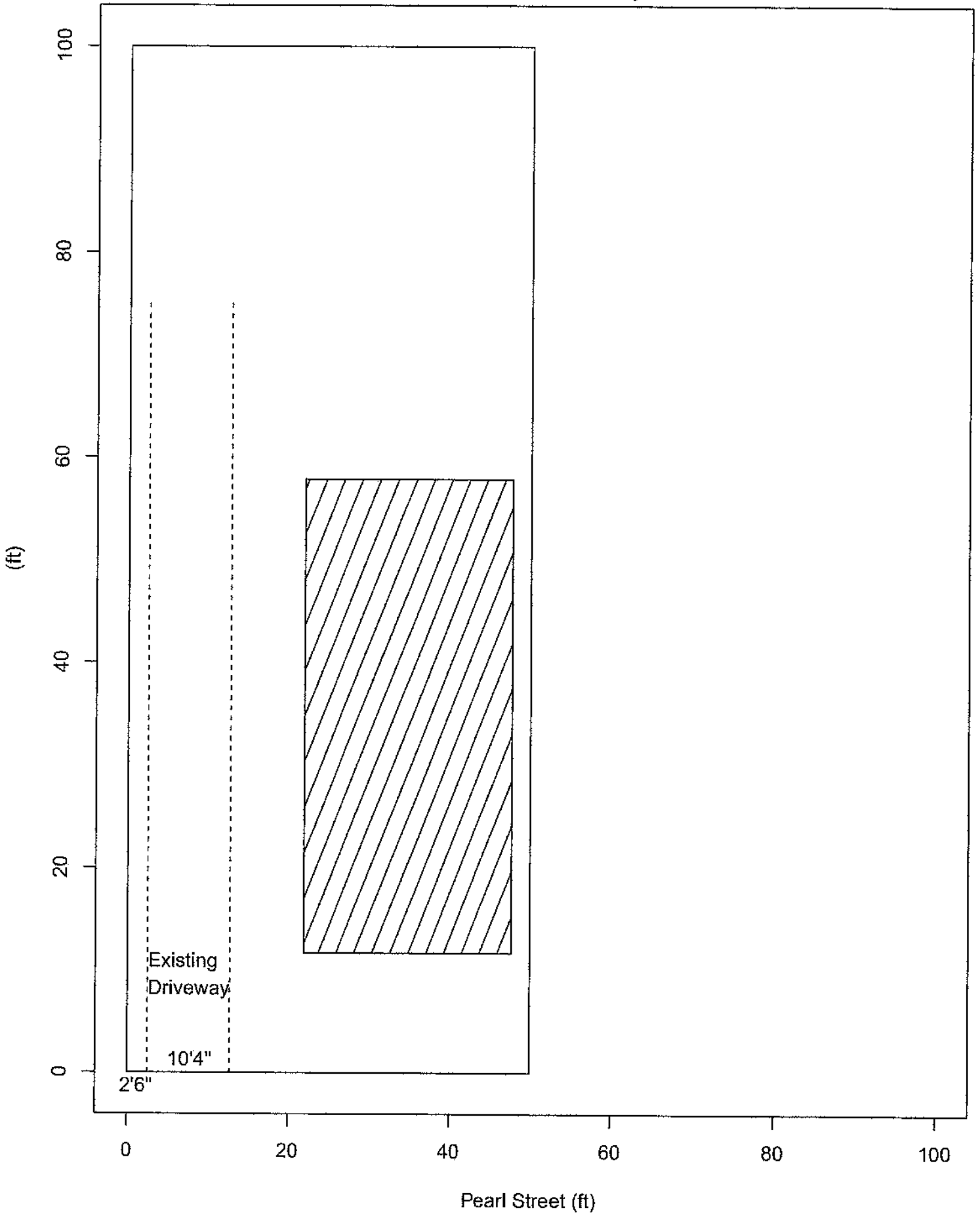

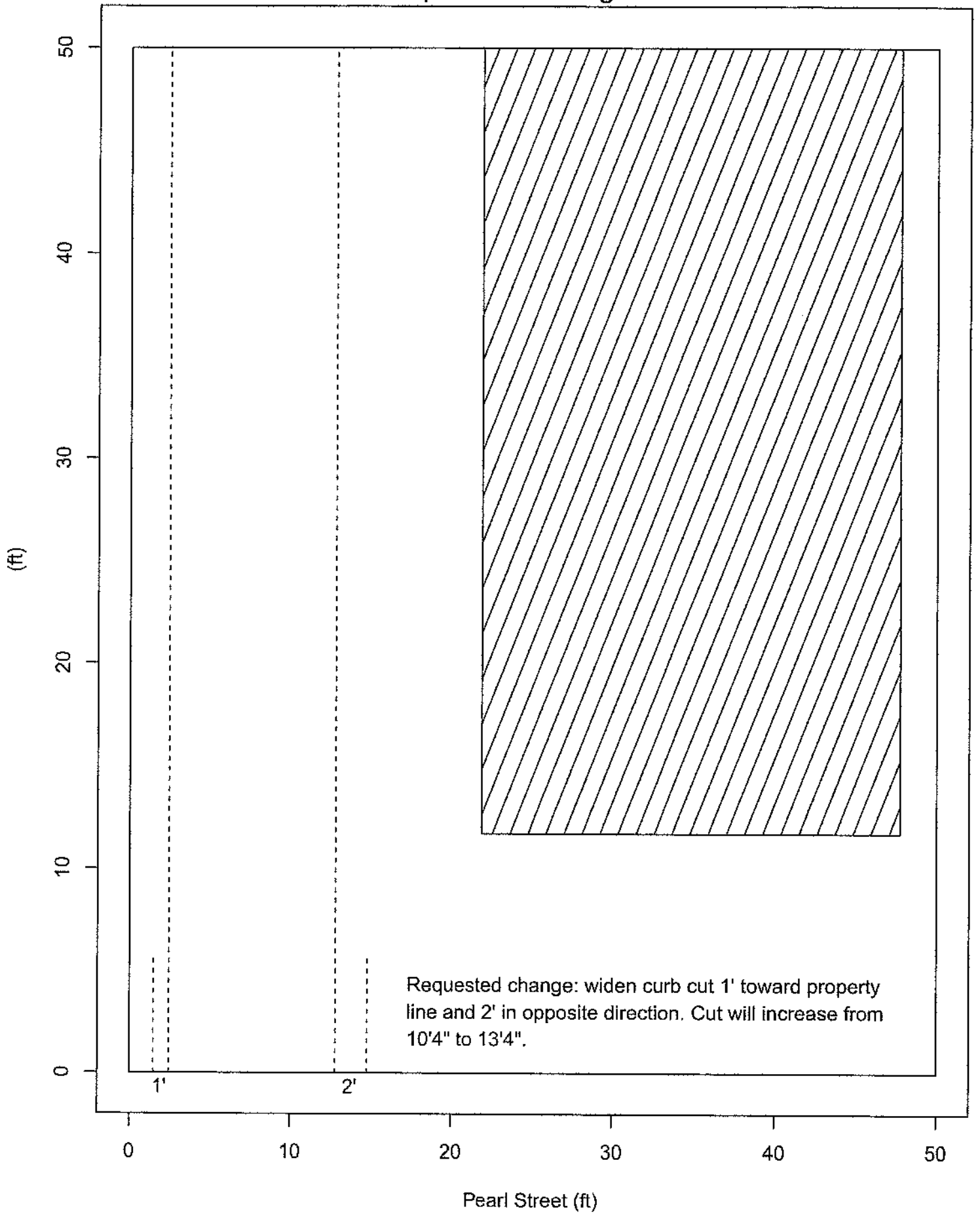

However, I urge you to make every effort to complete your review as soon as possible.
